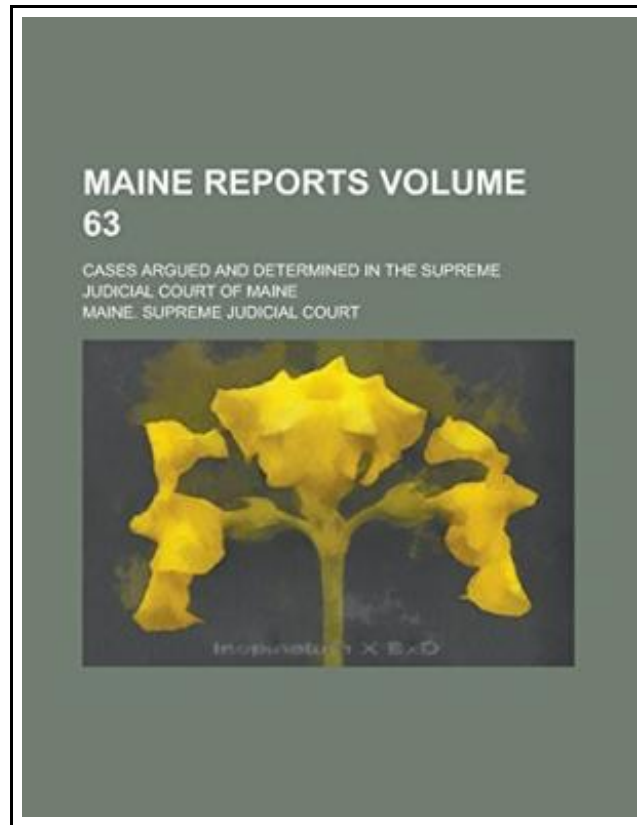

Excerpt: .these examinations the defendant professed himself unable, by reason of ill-health, to accompany them over the ground, but stated, in reply to inquiries about the boundaries, that if they kept between the fence and the creek they could not get off his land. The plaintiff's uncle wrote the conveyance between these parties, and, in obtaining the description, asked if the bounds stated orally, and contained in old deeds brought forward by Mr. Plaisted, included all the land they had been over, and all between the creek and the fence, and Mr. Plaisted replied that it did, and more too, because there was a heater piece down by the creek which was outside the fence. Between the creek and the fence, as it then stood, was a parcel of land, called the Hooper lot, for which the defendant had bargained, and paid the price, but had taken the note of the owner instead of a deed, saying that, as he (Plaisted) proposed to sell his farm, it would be as well for Mr. Hooper to make a deed direct to Plaisted's vendee, then take up his note; and Hooper had once executed such a conveyance, at Plaisted's request, but it was not used, owing to a failure to complete the sale of the farm.
